A. <u>S-15-17E</u> - Tulare City Wastewater Plant

On April 2, 2015, Hearing Board Chair, William L. Bland, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from April 2, 2015, until May 1, 2015. Said variance provided relief from specific requirements of District Rules 2070, 2201, and 2520 and allowed for the shutdown of the flare while it undergoes repair.

## B. <u>S-15-18E</u> - Alon Bakersfield Refining

On April 8, 2015, Hearing Board Chair, William L. Bland, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from April 7, 2015, until May 6, 2015. Said variance provided relief from specific requirements of District Rules 2070, 2201, 2520, and 4623 and allowed petroleum storage tanks to continue to store VOC containing liquids without a functional or operating vapor recovery system.

## C. S-15-19E - California Resources Production Corporation

On April 14, 2015, Hearing Board Chair, William L. Bland, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from April 13, 2015, until May 12, 2015. Said variance provided relief from specific requirements of District Rules 2070, 2201, 2520, and 4623 and allowed petroleum storage tanks to continue to store VOC containing liquids without a functional or operating vapor recovery system.

# D. <u>S-15-20E</u> - Aera Energy LLC

On April 16, 2015, Hearing Board Chair, William L. Bland, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from April 16, 2015, until May 15, 2015. Said variance provided relief from specific requirements of District Rules 2070, 2201, 2520, and 4623 and allowed petroleum storage tanks to continue to store VOC containing liquids without a functional or operating vapor recovery system.

## E. <u>S-15-21E</u> - Chevron USA Inc

On April 20, 2015, Hearing Board Chair, William L. Bland, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from April 17, 2015, until May 16, 2015. Said variance provided relief from specific requirements of District Rules 2070, 2201, 2520, 4401, and 4623 and allowed petroleum storage tanks to continue to store VOC containing liquids without a functional or operating vapor recovery system.

## F. S-15-22E - Chevron USA Inc

On April 28, 2015, Hearing Board Chair, William L. Bland, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from April 28, 2015, until April 30, 2015. Said variance provided relief from specific requirements of District Rules 2070, 2201, 2520, 4401, and 4623 and allowed petroleum storage tanks to continue to store VOC containing liquids without a functional or operating vapor recovery system.

## G. <u>S-15-27E</u> - Mt. Poso Cogeneration Company LLC

On May 4, 2015, Hearing Board Chair, William L. Bland, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from April 30, 2015, until May 29, 2015. Said variance provided relief from specific requirements of District Rules 1080, 2070, 2201, 2520, and 4352 and allowed for the continued operation of the power plant without an operational CO monitoring system.
