A. S-15-51E - California Resources Production Corporation

On October 15, 2015, Hearing Board Chair, William L. Bland, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from October 15, 2015, to October 18, 2015. Said variance provided relief from specific requirements of District Rules 2010, 2070, 2201, 2520, 4401, and 4623 and allowed for the continued storage of VOC containing liquids in the subject tanks and well casings without a fully functional and operating vapor recovery system while PG&E conducts their repairs.

B. S-15-54E - Chevron USA Inc.

On October 22, 2015, Hearing Board Chair, William L. Bland, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from October 22, 2015, to October 23, 2015. Said variance provided relief from specific requirements of District Rules 2070, 2201, and 4623 and allowed for the continued storage of VOC containing liquids in the subject tanks without a fully functional and operating vapor recovery system while Chevron conducts repairs on the electrical system.

C. S-15-57E - Chevron USA Inc.

On November 5, 2015, Hearing Board Chair, William L. Bland, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from November 4, 2015, to December 3, 2015. Said variance provided relief from specific requirements of District Rules 2070, 2201, 2520, 4401, and 4623 and allowed for the continued storage of VOC containing liquids in the subject tanks without a fully functional and operating vapor recovery system while Chevron conducts repairs on the vapor recovery system. It also allowed the flare to exceed its daily sour gas limit.
