 - A. <u>S-16-16E</u> Chevron USA Inc.

On April 18, 2016, Hearing Board Chair, William L. Bland, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from April 15, 2016, through May 14, 2016. Said variance provided relief from specific requirements of District Rules 2070, 2201, 2520, 4409, and 4623 and allowed for the continued storage of VOC containing liquids in the storage tanks and the use of the loading rack without a functional and operating vapor recovery system while the leaking Varec pressure/vacuum relief valves were replaced.
