On February 7, 2020, Hearing Board Chair, William L. Bland, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from February 10, 2020, through March 10, 2020. Said variance provided relief from specific requirements of District Rules 2070, 2201, 2520, 4401, and 4673, and allowed for continued storage of VOC containing liquids in the subject storage tanks without a functional and operational VRS. In addition, it will allow wells with closed casing gas vents to produce into tanks that do not have a functional or operating VRS.
