A. S-21-27E Sentinel Peak Resources CA LLC

On October 18, 2021, Hearing Board Chair, John Stovall, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from October 18, 2021, through October 20, 2021. The variance provided relief from specific requirements of District Rules 2010, 2070, 2201, 2520 and 4311, and allowed Sentinel Peak Resources to continue to operate with excess emissions while the blown tube in the convection box is repaired and the steam generator is returned to compliant operation.

B. S-21-29E CRPC Scorpion
