10. The Southern Region Hearing Board heard and granted the following emergency variances:

A. S-22-13E Pregis Innovative Packaging, Inc.

On July 19, 2022, Hearing Board Chair, John Stovall, acting for and on behalf of the Southern Region Hearing Board, approved an emergency variance from July 11, 2022, through August 9, 2022. The variance provided relief from specific requirements of District Rules 1080, 2010, 2070, 2201, 2520 and 4001, and allowed Pregis Innovative Packaging, Inc. to operate the facility without a certified CEMS while the analyzer was replaced and recertified.
