- 5. The Southern Region Hearing Board approved the following emergency variances orders:
  - A. Docket S-06-44E Mt. Poso Cogeneration Company

On July 10, 2006, Hearing Board Member Ms. Kimm Wolber, RN, COHN-S, approved an emergency variance from July 6, 2006, to August 4, 2006. Said variance provided relief from specific requirements of District Rules 1080, 2070, and 2201, and allowed continued operation of the combustion unit while the opacity monitor serving the combustion unit was repair.

## B. Docket S-06-46E – Chevron USA Inc.

On July 18, 2006, Hearing Board Member Ms. Kimm Wolber, RN, COHN-S, approved an emergency variance from July 14, 2006, to August 12, 2006. Said variance provided relief from specific requirements of District Rules 2070, 2201, and 4623 and allows the subject equipment to operate without a vapor recovery system while an electrical circuit breaker is replaced.

#### C. Docket S-06-47E – Chevron USA Inc.

On July 18, 2006, Hearing Board Member Ms. Kimm Wolber, RN, COHN-S, approved an emergency variance from July 18, 2006, to August 16, 2006. Said variance provided relief from specific requirements of District Rules 2010, 2070, 4623 to allow the flaring of the Station 1-09 vapor recovery gas during a non-emergency event and in addition to allowing operation of the subject tanks without vapor recovery.

### D. Docket S-06-48E – Chevron USA Inc.

On July 18, 2006, Hearing Board Member Ms. Kimm Wolber, RN, COHN-S, approved an emergency variance from July 18, 2006, to July 26, 2006. Said variance provided relief from specific requirements of District Rules 2201, 2070, and 4623 and allowed for the shutdown of the vapor recovery system to conduct maintenance on the vapor recovery system and the connection of three new water tanks.

## E. Docket S-06-52E – Chevron USA Inc.

On July 27, 2006, Hearing Board Member Ms. Kimm Wolber, RN, COHN-S, approved an emergency variance from July 26, 2006, to August 24, 2006. Said variance provided relief from specific requirements of District Rules 2010, 2070, and 4623 and allows for the continued operation of seven storage tanks without vapor recovery while portions of the gas trunk line are replaced.
