On December 14, 2005, Hearing Board member Ms. Kimm Wolber, RN, COHN-S, approved an emergency variance effective from December 14, 2005, to December 16, 2005. Said variance provided relief from specific requirements of District Rules 2070.7.0, 2201, and 4623 to allow continued receiving, storage, and/or processing of VOC containing fluids in the subject tanks without an operational VRS while Crimson Resource Management's 1-C Gas Plant is shutdown to allow PG&E to perform electrical maintenance.
