On June 14, 2006, Hearing Board Member Ms. Kimm Wolber, RN, COHN-S, approved an emergency variance from June 14, 2006, to July 12, 2006. Said variance provided relief from specific requirements of District Rules 2010, 2070.7.0, 2201, and 4623 to allow commissioning of the sulfur scrubber system with excess SO<sub>x</sub>, CO, and VOC emissions.

B. Docket S-06-39E – Bolthouse Farm

On June 14, 2006, Hearing Board Member Ms. Kimm Wolber, RN, COHN-S, approved an emergency variance from June 14, 2006 to July 12, 2006.
