1. CALL MEETING TO ORDER:

APPROVE MINUTES OF MAY 13, 2009

The Chair, Hollis Carlile, asked if there were any comments regarding the Minutes of May 13, 2009. Hearing none, the Minutes for May 13, 2009, were approved.

4. Public Hearing:

The Chair asked the Clerk to verify that all items had been properly noticed. The Clerk responded yes, they had been properly noticed. All those present to testify were sworn in by the Chair, and he requested that they sign in.

A. S-08-74X Extension Land O' Lakes, Inc.

Patrick Houlihan presented the report. Land O' Lakes, Inc. (LOL), is seeking an extension of the regular variance. The requested variance period would be from June 1, 2009, to November 30, 2009, or until the new boiler is installed and operational. LOL is requesting to run the old one until the new one is ready.

Petitioner, Doug Findley, stated they initially came in for a six month variance, but found out the gas company cannot provide the sufficient gas load to the new boiler. They need an extension to allow time to get the new boiler on line with the current source. They may need additional time until the gas company installs a new gas line to the facility. Boiler #6 can be taken off line once the new boiler is ready. They anticipate getting it done before the end of the year.

Mr. Carlile asked questions about the length and width of the line to be added. Mr. Tiegen answered they would allow the existing line to stay in place to supply the current equipment and the new separate line would be dedicated to the new boiler. Ms. Wolber asked what size line the gas company would be installing. Mr. Tiegen answered they have not been given that information, but believe it will be a bigger line.

B. S-09-28R Regular Elk Hills Power, LLC

George McMurren Marilyn Teague Patrick Houlihan presented the report. Elk Hills Power, LLC (EHP), is seeking a regular variance for the period between June 10, 2009, and June 10, 2010, to allow the continued operation of the facility while emitting excess particulate matter from the cooling tower.

Mr. Houlihan stated there is a slight correction to be made to the District's Staff Report. Page three, first paragraph under Recommendations, should read:

"Should the Southern Region Hearing Board make the required findings and move to grant a *regular* variance to Elk Hills Power, LLC, the District recommends the following conditions:"

George McMurren stated they are using more water than they are allotted by West Kern Water District, which limits the operation of their facility. By allowing them to increase from 9.4 pounds per day to 18, they would be able to continue operating with the same amount of water they originally planned on using.

C. S-09-29S Short South Kern Industrial Center, LLC

Patrick Houlihan presented the report. South Kern Industrial Center, LLC (South Kern), is requesting a short variance period from June 10, 2009, until September 8, 2009, to allow the ASP (aerated static pile) to be shut down for preventative inspection and maintenance.

Petitioner, Douglas McCormick stated South Kern has been in operation continuously since 2007 without maintenance. The plant must be shut down for preventative maintenance.

Mr. Carlile asked what the manufacturer's recommendations are in regard to maintenance. Ms. Loder answered quarterly, monthly, annual, semi-annual, but to

do so, the equipment must be shut down. An inspection must be done now to avoid an emergency in the future.

Mr. Stovall asked if shutting down would create odor problems for communities nearby. Mr. McMurren answered the only plant nearby is Taft Manufacturing, which is located upwind. They don't expect any odors to come off of this operation.

Ms. Loder added that they will not be moving any materials during the inspection and will be placing a compost blanket over the top of the compost piles.

D. S-09-31S Short Pregis Innovative Packaging

Patrick Houlihan presented the report. Pregis Innovative Packaging, Inc. (Pregis) is requesting a short variance period from June 15, 2009, until September 10, 2009, to allow Pregis to operate the RTO (regenerative thermal oxidizer) at a temperature below 1500° F for purposes of source testing.

Petitioner, Sharon Davenport, stated that due to the recession and lower demands, they must shut down on weekends. Pregis has encountered problems meeting permit limits in periods of low production. A variance is being requested in order to run an experiment to determine if lower temperatures yield the same destruction efficiency. Ms. Davenport added they would probably only need from July 10th through the 13th.
