A. S-09-70i Interim Occidental of Elk Hills, Inc.

Patrick Houlihan presented the report. Occidental of Elk Hills, Inc. (OEHI) is seeking an interim variance for a period between December 18, 2009, and March 10, 2010, to allow for the storage of VOC containing liquids without an operational or functional vapor recovery system (VRS).

Patrick Houlihan pointed out a change to the staff report. Page three (3), Recommendation four (4) should read as follows:

4. Excess VOC emissions shall not exceed *45.3* pounds per day during the variance period.

Petitioner, Rick Garcia, stated their petition was covered thoroughly and only went over the required findings.

Mr. Carlile asked about the gravity of the oil. Ms. Dunn questioned the timeframe of the variance. Patrick Houlihan cleared up any questions she had.

John Stovall recused himself from the meeting due to a conflict of interest, as he owns stock in Occidental of Elk Hills.

B. S-09-71S Short Aera Energy, LLC

Petitioners: Robert Beebout

Patrick Houlihan presented the report. Aera Energy, LLC (AERA) is seeking a short variance for a consecutive period of 56 hours to occur sometime between January 25, 2010, and April 25, 2010, to allow the continued storage of VOC containing liquids at the subject leases without an operational vapor recovery system.

Hollis Carlile pointed out a correction on page four (4) of the staff report. Strike out 48 and put in 56. Number one (1) of the recommendations should read as follows:

 The variance shall be effective for a consecutive period of 56 hours to occur sometime between January 5, 2010, and April 25, 2010, or until PG&E restores electrical power and compliance is re-established, whichever occurs first.

Petitioner, Robert Beebout, stated the District accurately summarized their situation. PG & E notified them of their upcoming maintenance and therefore, electrical power would be shut off to some of AERA's leases sometime in February of 2010. This variance request is a result of PG & E's scheduled power outage.
