A. S-10-01X Extension Occidental Of Elk Hills, Inc.

Patrick Houlihan presented the report. Occidental of Elk Hills, Inc. has requested an extension of the regular variance previously granted on February 10, 2010 until June 30, 2010 (S-10-01R). The requested variance would be a period between July 1, 2010 and September 20, 2010. If granted, the variance would allow the subject heaters to operate while the cogeneration plants are in operation and allow for excess NO_x and CO.

The District believes that the required findings can be made and recommends that Occidental Of Elk Hills, Inc. be granted the extension of the previously granted regular variance with the conditions as stated on pages five, six, and seven of the staff report.

Petitioner, Dennis Champion presented the numerous difficulties that OEHI has encountered with keeping an antiquated system in compliance by redesigning and making modifications.

Hollis Carlile commented on his concerns that September 30, 2010 would not be enough time to complete this project. Based on this concern, an end date of December 31, 2010 was granted after being mutually acceptable to all parties.

Condition #14 should read: By January 15, 2011, OEHI shall submit a written report to the district. The rest of that paragraph is to remain intact.

Patrick Houlihan presented the report with one noted correction. On page two, under "Previous Variance" heading, the date should read: *May 13, 2009*. The rest of that paragraph is correct.

PFI has requested an extension of the previously granted regular variance from District Rule 4307. The requested variance would be from July 1, 2010 to July 1, 2011. If granted, the variance would allow the use of the pasteurizer with NO_x and CO emissions in excess of those limits which are allowed by Rule 4307. If the Rule is not amended or if another solution does not arrive by July 1, 2011, the District will support PFI filing for another extension until such action can be taken.

The District believes that the required findings can be met and recommends that PFI be granted an extension of the previously granted regular variance with the conditions as stated on pages four and five of the staff report.

Petitioner, Doug McCormick, thanked Patrick Houlihan for his help and stated the District's presentation accurately captured their petition. He presented new information. During the monthly monitoring, it was discovered that this unit operates very cyclically with regard to temperatures, making it impossible for this unit to comply with Rule 4307. In looking at different burner technology with the same heat specifications required for pasteurization, and the cyclic nature of heat demand, we still do not think a different burner would achieve compliance.

If granted, the variance would allow the continued storage of volatile organic compounds (VOC) containing liquids in the tanks without a functional or operating vapor recovery system (VRS).

Patrick Houlihan presented the report. CUSA has requested a short variance from the requirements of District Rules, in addition to the applicable conditions of the subject Authorities to Construct (ATCs) and permits to operate (PTOs). The requested short variance period would be effective for a non-consecutive 14-day period to occur between July 15, 2010 and September 15, 2010. If granted, the variance would allow CUSA to continue to store VOC containing liquids in tanks without a functional or operating VSR while CUSA conducts maintenance on a soft water tank and piping. In addition, it will allow wells with closed casing vents to produce into tanks that do not have a functional or operating VRS.

The District believes that the required findings can be met and recommends that CUSA be granted a short variance with the conditions as stated on pages four, five, and six of the staff report.

Petitioner, Martin Lundy, thanked Patrick Houlihan for his help and stated that the District's presentation accurately captures the content of CUSA's petition and finds the staff report acceptable.

Petitioner, Martin Quintero, stated that this system was put in place in the early 1980's on a foundation that promoted underside corrosion, which was a design error. CUSA is taking steps to make sure that this problem does not happen again.

The requested interim variance period will be from July 14, 2010 until September 8, 2010, or until the Southern Region Hearing Board can hear the petition for the regular variance, whichever occurs first. If granted, the variance would allow for the continued operation of the metal parts coating operation controlled by a VOC control device that does not meeting 90% control efficiency.
