3. <u>APPROVE MINUTES OF MAY 9, 2012</u> The Chair, Hollis Carlile, asked if there were any comments regarding the Minutes of May 9, 2012. Hearing no comments, the Chair declared the minutes were approved as submitted.

Petitioner: Ted Guth

RBP has requested a regular variance from District Rules 2070.7.0, 2201, 2520, and 4352, in addition to conditions of the applicable Permits to Operate (PTOs). The requested variance period would be from June 13, 2012, until July 11, 2012. If granted, the regular variance would allow RBP to operate with excess CO, VOC, NO_x , and SO_x emissions while they ramp up and down, utilize various fuel mixture ratios, and operate at reduced loads.

Mr. Guth thanked Mr. Houlihan for the staff report and thanked the Board for allowing the Interim variance back in May. RBP has been trying not to have excess emissions. He added that after 23 years of being in operation full time, they have to limit operation to peak daytime hours during the summer months. Mr. Guth stated they have various types of fuel to try and expressed a desire to extend the period to October 2012.

Mr. Stovall inquired if RBP is planning to ask for an extension or asking to change the wording on this Petition.

Mr. Houlihan stated the date on the Petition could be amended to show the requested variance period would be from June 13, 2012, until October 15, 2012.

As such, Recommendation number 11 on page five (5) of the report will read as follows: By October 30, 2012, or no later than 15 days after completing the trial period, RBP shall submit a written report to the District.

Having decided the petition has met the required findings, on motion of Mr. Stovall and seconded by Dr. Haddock, unanimously passed, the petitioner was granted a regular variance.

BOWMAN has requested an extension of the previously granted regular variance from District Rules 1081, 2010, 2201, and 4309, in addition to conditions of the applicable ATC. If granted, the variance would allow BOWMAN to postpone the start-up compliance source test until an order of sufficient quantity will allow for a source test.

MOC has requested a short variance from District Rules 2010, 2070.7.0, 2201, and 2520 in addition to the applicable conditions of the ATC and PTO. The requested variance period will be effective from June 18, 2012, until August 16, 2012, inclusive. If granted, the variance would allow the subject tank to be isolated from the VRS so that it can be cleaned, inspected, and repaired.

Mr. Houlihan stated MOC has requested a change in the report. Page 4, Condition number six, Item C, to read as follows: *Fill tank with clean produced water.* Item F to read as follows: *Drain the clean produced water into the process system*.

Mr. McCormick stated the tank has filled up with sediment. MOC built a new tank and are in the process of cleaning and repairing the old tank.

Dr. Haddock pointed out a 90 day variance period would be from June 18, 2012 to September 16, 2012, not August 16, 2012, as stated in the staff report.

Mr. Houlihan stated the staff report will be changed to show the requested variance period will be effective from June 18, 2012, until September 16, 2012, inclusive.

As such, Recommendation number 11 on page five (5) of the report will read as follows: By October 1, 2012, or no later than 15 calendar days after the tank resumes operating under the VRS, whichever occurs first, MOC shall submit to the District a summary report...
