Foster Farms has requested an interim variance, to be followed by a regular variance, from the applicable requirements of District Rule 2010, 2201, 4305, 4306, and 4320 in addition to the applicable conditions of the ATC. The requested variance

period would be from June 12, 2013, until August 14, 2013, or until the petition for the regular variance has been heard, whichever occurs first. If granted, the variance would allow for the continued operation of the subject heater with excess emissions of  $NO_x$  and CO.

Mr. Duke commented the facility will replace the unit.

Mr. Bland asked the petitioners if a work schedule will be available when the regular variance is requested. Mr. Duke responded affirmatively adding that the facility staff is currently developing a proposed schedule.

Ms. Dunn asked the age of the equipment. Mr. Duke responded the equipment was approximately 13 years old. Ms. Dunn asked if the equipment ran all the time. Mr. Ortiz explained the equipment runs 16 hours per day except Sundays.

Mr. Stovall commented the shutdown of the facility would cause several persons to become unemployed. Dr. Haddock commented the shutting down of the facility would have a ripple effect and cause truckers to lose profits as well.

Having decided the petition has met the required findings, on motion of Mr. Padilla and seconded by Dr. Stovall, unanimously passed, the petitioner was granted a short variance.
