PTOs. The requested short variance period would be effective for a non-consecutive 21-day period to occur sometime between August 15, 2013, and November 12, 2013, inclusive. If granted, the variance would allow CUSA to continue to store VOC containing liquids in the subject tanks without a functional or operating VRS while CUSA conducts the subject maintenance.

Mr. Houlihan presented a photo of the where the facility is physically located. Mr. Houlihan noted an addition to Condition #1:

The variance shall be effective for a non-consecutive 21-day period to occur sometime between August 15, 2013, and November 12, 2013, inclusive, or until the subject maintenance is completed and CUSA has returned the VRS to compliant operation, whichever occurs first.

Ms. Dahlstrom thanked Mr. Houlihan for his presentation and had no further comments.

Mr. Stovall asked for more information on a liquor scrubber. Mr. Enns explained the equipment is part of the SO_x scrubber.
