Patrick Houlihan presented the Staff Report.

Ripon has requested a short variance from the requirements of District Rules 2070.7.0, 2201, 2520, and 4703 in addition to the applicable conditions of the subject PTOs. The requested short variance period would be for a non-consecutive two day period to occur sometime between January 25, 2014, and March 1, 2014, inclusive. If granted, the variance would allow the operation of the subject turbine with excess  $NO_X$  emission while the performance tests are conducted.

Mr. Brussee stated he submitted supplementary calculations outlining the methods used for estimating the emissions calculations during the hours of start-up and shutdown which are based on the EPA equation 19.1.
