SJVUAPCD Southern Region Hearing Board Action Summary Minutes April 13, 2016

The District has requested a stipulated order of abatement to require the respondent to cease violation of District Rules 1081 and 2010 by either ceasing operations, or, in the alternative, complying with the Conditions of the Stipulation.

Ms. Williamson explained the California Health and Safety Code authorizes the Hearing Board to issue Stipulated Orders of Abatement when the facility is operating in violation of rules and regulations. Normally violations are settled with fees and the facility works to get back into compliance. If the facility does not get into compliance then there is a civil action in Superior Court. A Stipulated Order of Abatement is swifter when agreed upon and has specific conditions to achieve. This method is also an incentive for the facility to continue to work on getting into compliance or the consequence is to go to court.

Ms. Williamson reviewed the violations by Media Index Publishing and the specific conditions as stated in the Stipulated Order of Abatement. She added the Stipulated Order of Abatement expires after the first annual test.

Mr. Bland asked how the District arrived at the monetary figures in the conditions. Ms. Williamson explained the conditions were derived from straight civil penalties and part by cost avoidance.

Mr. Miles stated the conditions have been agreed upon and a source test is scheduled for April 19, 2016.

Having decided the petition was in order, on motion of Mr. Stovall and seconded by Dr. Haddock, unanimously passed, the Hearing Board authorized the Stipulated Order of Abatement.
