Mr. Houlihan presented the Staff Report.

Chevron has requested a short variance from the applicable requirements of District Rules 2010, 2070, 2201, 2520, 4409, 4624, and 4623, in addition to the applicable conditions of the subject permits. The requested variance would be for a non-consecutive 72-hour period to occur sometime between March 9, 2016, and June 7, 2016, inclusive. If granted, the variance would allow the continued storage of VOC containing liquids in tanks without a functional or operating VRS while the repairs are performed.

Mr. Padilla asked the size of the casing and the kind of road. Mr. McLemore explained the road is private and the casing is 8 inches with a 6 inch pipe running through it, the length being replaced is approximately 40 feet. Mr. Padilla asked what measures are being taken to minimize emissions. Mr. McLemore replied completing the work as soon as possible.
