California Resources Production Corp has requested a regular variance from the applicable requirements of District Rule 4623. The requested variance would be from January 31, 2017, until January 30, 2018. If granted, the variance would allow for the storage of VOC containing liquids without an operational or functional VRS until California Resources Production Corp can install a VRS.

Mr. Kalashian presented the Staff Report.

CHEVRON has requested a short variance from the applicable requirements of District Rules 2070, 2201, 2520, 4401, and 4623, in addition to applicable conditions of the subject permits. The requested variance period would be for a non-consecutive 240-hour period to occur sometime between March 13, 2017, and June 10, 2017, inclusive. If granted, the variance would allow CHEVRON to continue to store VOC containing liquids in the subject tanks without an operating or functional

VRS while they conduct the maintenance and upgrades at the 26C OCP. In addition, it will allow wells with closed casing gas vents to produce into tanks that do not have a functional or operating VRS.

Petitioner comment: Mr. Rickards directed his question to Mr. Kalashian and commented that there are additional permits & conditions that the facility would need relief from.

Mr. Kalashian responded by referring to the recommendations found on page 4, item # 2 & stated that there are more conditions besides (condition 5 of PTO's S-1128-0-2; and conditions 1 and 2 of PTO S-1128-989-1). Mr. Kalashian mentioned that the additional conditions are: Condition 4, 6, 7, 10, 14, 15, 16, 17, 18, 20, 27, 28, 29 & 37 of PTO S-118-22 and also one for unit 1141-0-5 for Conditions 5, 114 & 115 and the last one that is different is 1141-430-14 Condition 1, 5, 6, 9 & 10. Mr. Kalashian clarified that this would not change the language that is in the petition / staff report.

Mrs. Fierro commented: Should the chair choose to make a motion to approve this variance they could make comment that they are including the minor clarifications to recommendations 2 & 4.

Petitioner comment: Mr. Rickards commented by saying that he appreciates the last minute change.
