Chevron requested a short variance from applicable requirements of District Rules 2070, 2201, 2520, 4623, and 4703 in addition to the applicable conditions on the subject permits. The requested short variance period would be for a non-consecutive 24 hour period to occur sometime between August 10, 2017, and September 30, 2017, inclusive. If granted, the short variance would allow for the operation of the subject turbines with excess emissions. In addition, it would allow the continued storage of VOC containing liquids in the subject tanks without a functional or operating VRS.

Mr. Padilla clarified that testing will be of the internal power system and asked how long the Kern Oil field will be separated from the grid when PG&E performs their testing.
