If granted, the variance would allow Chevron to continue to store VCO containing liquids in the subject tanks without an operating or functional VRS while they conduct the maintenance and upgrades at the 26C OCP. In addition, it will allow wells closed casing gas vents to produce into tanks that do not have a functional or operating VRS.
