Aera Energy LLC, Emergency Variance granted to provide relief from specific requirements of District Rules 2010, 2201, and 4623 to allow the continued storage of VOC containing fluids in the subject tanks and gas flotation units without VRS while power to the facility is curtained and maintenance activities are conducted.

B.) Docket S-05-36E

Big West of California, LLC, Emergency Variance granted to provide relief from specific requirements of District Rules 2070.7.0, 2080, 2201, 2520, and 4623 to allow the continued storage of VOC containing fluids in the subject storage tanks without an operational VRS while VRS #8 is shutdown and the float valve in the compressor's discharge knock out is replaced.
