Brian Dodds presented the report. Mr. Winn thanked the staff for their work on the report and said they concurred with the Staff's conclusions. He clarified that on page three under Recommendations, Item 3, would more properly be stated "the variance shall allow continued operation of the drain vessel while isolated from VRS" rather than as stated in the report. He added that the rest of the report reflects that intent. Mr. Dodds concurred.

B. Short Variance Docket Number S-07-10-S: Phoenix Bio Industries, 31120 Nutmeg Road, Goshen, CA 93227

Petitioners: Adrien Galvez, Altra Biofuels (Phoenix Bio Industries LLC), Mark Mullen, Altra Biofuels a Phoenix Bio Industries LLC).

Brian Dodds presented the report. Ms. Wolber asked how long it will take the company to complete the repairs. Mr. Dodds said that they must get an authority to construct before they can begin work, but should complete the work by April 19; Phoenix Bio Industries has requested the entire 90 days should unforeseen complications arise. Mr. Galvez concurs with the staff report. He stated that when Phoenix Bio Industries took over the facility, they discovered that the previous test method used was outdated. Phoenix Bio recognized this fact, and suspected they might be out of compliance. They immediately began the process to order and install a regenerative thermal oxidizer. The Chair wanted to know how the original facility was allowed to operate without meeting the District's requirements. Mr. Galvez stated that the original facility used old test methods, and under those methods, it met

the requirements; however, under the new testing methods it does not. The Chair stated that this is a situation in which no one is at fault.
