Docket No. S-01-20R, Regular Variance, Aera Energy LLC, 59231 Main Camp Road, McKittrick CA. 93251. Type of Business: Crude Oil and Natural Gas Production & Processing.

<u>Petitioner</u> – Jim Marchesini and Brent Winn represented Aera Energy, LLC.

Mr. Marchesini and Mr. Winn presented to the Board and staff with a power point presentation with handouts of their presentation regarding Aera Energy LLC, Belridge Gas Plant Construction Variance, Docket No. S-01-20R.

Public Comments – No Public Comments.

<u>Decision</u> – Mr. Dean moved that the variance be granted. Mr. Dean stated that the required six findings set forth on pages 2 and 3 of the Staff could be made per the testimony presented by staff and the Petitioner. The motion was seconded by Ms. Wolber and carried unanimously with the following <u>Roll Call</u> Vote:

The following conditions were revised during the hearing: (1.) the variance shall be for a consecutive seventy-seven (77) day period to occur sometime between February 1, 2002 and October 18, 2002 (7.) Petitioner shall monitor on a daily basis (which may be changed at the District's discretion) (8) due date for written report changed to November 18, 2002 or 15 days after compliance is achieved
