3. Approve Minutes of December 12, 2001 – The Chairman asked if there were any corrections, comments or additions to the Minutes. The Board did not have any corrections, comments or additions to the Minutes. Therefore, the Chairman declared the Minutes of December 12, 2001 approved as submitted.

The Chairman requested the Petitioners to sign the Sign In Sheet.

All persons testifying were sworn in by the Chairman.

The Chairman asked if the Petitions have been properly noticed and on file with the Clerk to the Board. Ms. Smith responded affirmative.

The Chairman requested that the Hearing Board Packet and any additional materials provided during the hearings be entered into the Official Record.

4. Public Hearing:

Michael Carrera presented the Staff Report.

Docket No. S-01-54S-R, Short Regular Variance, O. H. Kruse, 11518 Road 120, Pixley, CA. 93256. Type of Business: Dairy Feed Manufacturing.

Petitioners – Rick Watson and Bob Weatherly represented O. H. Kruse.

Amelia Yuan provided additional testimony for the District.

<u>Public Comments</u> – Clifton Calderwood stated that O. H. Kruse applied for the variance under the name of O. H. Kruse. But, Mr. Calderwood stated that O. H. Kruse applied for a transfer of ownership in July of 2001 to Hillman Holdings LLC. Mr. Calderwood noted that this is something that the Board might want to discuss.

Mr. Jay stated that the variance will be released to whoever holds the Permit to Operate.

Decision – Mr. Bland made a motion to grant the variance with the eight conditions set forth on pages 3 and 4 of the Staff Report with an amendment to condition # 4 and the required six findings set forth on pages 2 and 3 of the Staff Report be incorporated in the motion by reference. The motion was seconded by Ms. Wolber and carried unanimously with the following **Roll Call Vote**:

Noes: None. Absent: None.

The Board granted a Regular Variance to Docket No. S-01-54R, O. H. Kruse, the variance shall be effective from October 29, 2001 to February 2, 2002 or until compliance is achieved, whichever occurs first. The eight conditions with an amendment to Condition # 4 (shall not exceed 40% opacity) will be set forth in the Order.

- 7. <u>Hearing Board Member Comments</u> Marvin Dean stated that he would like to see in future Staff Reports a clear indication of the District's position of approval or denial of a Petitioner's request for a variance. (The remainder of the Board had no comments regarding Mr. Dean's request.)

Mr. Dean thanked Mr. Jay for his written comments in respect to clarification regarding Brown Act provisions that require general public comment on agendas. Mr. Dean commented that the only reason that he raised the issue is the fact of being a member appointed to represent the public. Mr. Dean noted that when a member of the public comes to the Board and provides Public Comment he wants to make certain that we are doing everything we can do to address the issue raised before us. So, that we can try and find a way to hear the issue or provide some type of guidance to the public.

Philip M. Jay, District Counsel, asked Mr. Dean to keep in mind the following: don't confuse being a public member with being a member that represents the public. All of the Board in a sense represents the public. But, you really are supposed to act like judges and be neutral and not really advocate one way or another. You're trier's of fact. So, the fact that yes, you're a public member in the sense that you're not the engineer member or the attorney member doesn't necessarily mean you're an advocate for one side or the other. You are to be neutral and be a judge. Mr. Jay stated that he likes to point that out whenever he can.
