- 8. The release of VOC emissions shall be minimized by operating the vapor recovery system whenever possible practicable.
- 9. All tanks affected by the vapor piping modifications shall remain static or be drawn down during the variance period. The Petitioner will attempt to minimize fluctuations in liquid and tank temperatures to the fullest extent practicable.
- 11. By November 3-17, 2003, or no later than 15 days after the end of the variance period, the Petitioner shall submit to the District a summary report that shall include all the information required above.
