Docket S-03-42S, Short Variance, Chevron USA, Inc., Sec. NE05, T29S, R28E, Bakersfield, CA. Type of Business: Heavy Crude Oil Production Facility

**Petitioner** - Larry Landis and Al Elrabaa represented Chevron USA, Inc.

The Petitioner requested a change to the variance start date from March 10, 2004 and April 9, 2004 to April 1, 2004 and April 30, 2004.

Staff indicated they were agreeable to a change in the variance start date.

**Public Comments** – No Public Comments.

<u>Decision</u> – Board Member Wolber made the motion to grant the Short Variance to Docket S-03-42S, Chevron USA, Inc., subject to eight conditions set forth on page 4 of the Staff Report with a revision to Condition # 1 regarding the variance start date. Docket S-04-10i, Interim Variance, Chevron USA, Inc., Sec. SW31, T29S, R22E, Bakersfield, CA. Type of Business: Crude Oil & Gas Production Facility.

Petitioners - Larry Landis and Ferry Martin represented Chevron USA, Inc.

Mr. Landis indicated the original variance request was for eleven tanks and has been revised to fourteen tanks. Mr. Landis read into the record the additional PTO's to be included in the variance request. #S-011-28-411, 412 and 936.

<u>Public Comments</u> – No Public Comments.

<u>Decision</u> – Board Member Wolber made the motion to grant the Interim Variance to Docket S-04-10i, Chevron USA, Inc. Ms. Wolber indicated the Hearing Board finds that just cause does exists in respect to the required six findings. The variance is subject to sixteen recommendations set forth on pages 3, 4 and 5 of the Staff Report as amended during the hearing. Seconded by Board Member Dunn and carried unanimously with the following *Roll Call Vote:*
